



3, ENGINEERING PROJECTS:

We also carry out all our engineering works using right standard, tools and workforce. A few of these include:

a) Water works

Dredging, drilling boreholes, dam construction and installation of overhead tanks and water reservoir, construction and installation of irrigation facilities, structural water works, pipeline design and fitting, geographical and hydraulic conductivity studies, aquifer analysis, borehole development, pump test, installation and maintenance works, flood control and routing, water analysis etc.





The borehole drilling operation is affected in stages viz:

Stage 1: Geological survey. The initial step is to undertake a geological survey to determine the depth of the aquifer, good drinking water and long lasting one. This is the feasibility work which will

reveal the water level and rock basement which will enable us achieve a perfect work.

Stage 2: We drill between 35-100 meters depending on the geographical survey report showing the water level and basement rock. The basement rock does not pose much challenge as we have the needed set of equipment to ensure success of the exercise.

Stage 3: Drilling. Casting, development and installation, etc.

Stage 4: Mechanical and plumbing work, DPC waste piping, water supply, channel piping, connections at input and out nut pipes. Fixing of all sanitary fittings, etc.

b) Civil Engineering works


